CASES HANDLED (as counsel and as neutral)

I. As Counsel

Ad Hoc Arbitration

Handled, as counsel, the following ad hoc domestic arbitrations:

- Dispute between a mall owner and its contractor regarding a construction dispute (represented the mall owner); and
- Dispute between a private entity and a government owned and controlled corporation regarding the termination of a contract (represented the private entity).

Currently handling an ad hoc arbitration commenced by a private entity against a Department of the Philippine Government regarding the latter's non-payment of the private entity's compensation for a completed government project (represents the private entity). The Integrated Bar of the Philippines (IBP) is currently processing the private entity's request for default appointment of the second arbitrator.

Institutional Arbitration

Also handled, as counsel, the following institutional arbitrations:

- 1) Before the ICC
 - Dispute between a Netherlands company and a Philippine company regarding their Marketing and Supply Agreement (represented the Netherlands company); and
 - Dispute between two (2) shareholders (a foreign company and a Philippine company) regarding their Shareholders' Agreement (represented the foreign company) [Dispute later settled at the initial stages of the arbitration].

2) Before the SIAC

- Dispute between a foreign company and a Philippine company regarding a Management Agreement over a hotel and resort development (represented the foreign company); and
- Dispute between a Philippine company/Project Owner of a solar power plant and its former Owner's Engineer (a foreign company) (represented the Philippine company) [Dispute later settled at the initial stages of the arbitration].

3) Before the PDRCI

• Dispute between a financial institution and a software developer over the parties' agreement for the supply of a comprehensive software system for use of the financial entity's customer care department (represented the financial institution).



4) Before the CIAC

- Dispute between a project owner and contractor regarding a hydroelectric power plant (represented the contractor);
- Dispute between a project owner and electrical contractor over the latter's delays in its works for a condominium project (represented the project owner); and
- Dispute between two (2) project owners and their common contractor regarding the latter's claim for payments for its works in the project owners' cold storage facilities (represents the project owners).

Currently handling an ICC arbitration between a lessor and lessee dispute over the former's termination of the lease agreement used by the lessee to house its depot. The tribunal is in the process of being constituted.

Court actions relating to arbitration

Has also handled, as counsel, the following court applications/petitions brought in aid of, or in relation to, pending and soon to be commenced arbitrations:

- Petition to compel arbitration before the Regional Trial Court of Pasig City (represented the petitioner);
- Petition for interim measure of protection before the Regional Trial Court of Quezon City (in relation to a soon to be commenced arbitration) (represented the petitioner);
- Petition for interim measure of protection before the Regional Trial Court of Makati City (in relation to a soon to be commenced arbitration) (represented the respondent);
- Petition for interim measure of protection before the Regional Trial Court of Manila (in relation to a soon to be commenced arbitration) (represented the petitioner);
- Petition for enforcement of a foreign arbitral award rendered by the ICC before the Regional Trial Court of Manila (represented the petitioner);
- Petition for enforcement of an arbitral award in a local international arbitration rendered by the SIAC before the Regional Trial Court of Manila (represented the petitioner); and
- Petition for confirmation of an arbitral award in a domestic arbitration rendered by the PDRCI before the Regional Trial Court of Makati City (represented the petitioner).

Currently has a request being processed by the President of the IBP for the default appointment of the second arbitrator in the ad hoc arbitration between its client private entity and a Department of the Philippine Government regarding the latter's non-payment of the private entity's compensation for a completed government project.
