ELOY E. BELLO IV has been in the private practice of law in the Philippines for thirty seven (37) years, from 1985 to the present. He is a Senior Partner of the law firm **Bello Valdez & Fernandez [formerly Bengzon Narciso Cudala Jimenez Gonzales & Liwanag** or "**The Bengzon Firm**"; a medium sized full service firm founded in 1951 by the late Justice Jose Bengzon, and his son, Jose F.S. Bengzon Jr., with about thirty (30) lawyers. He is the current Chairman of the Firm since 2016 and is currently the Operations Partner since 2019. He has also occupied various positions in the firm's Management Committee.
